Textual Information(1)	The Promoters i.e. Mr. Rohit Relan, Mrs. Ritu Relan, Mr. Rishabh Relan, Mr. Pranav Relan and Mr. Ayush Relan executed Gift Deeds dated 26th September, 2025 for the purpose of transferring 1,73,95,361 equity shares and voting rights held by them to the family trust, in order to streamline the succession, welfare of their family members and their lineal descendants pursuant to SEBI Exemption Order dated August 13, 2025. As a result of these transactions, the said Trust i.e. Rohit Relan Family trust was added in Promoter Group category w.e.f. 26th September 2025. Pursuant to clause 4(g)(ix) of SEBI exemption order dated August 13, 2025, the Acquirer Trust shall confirm, on an annual basis, that it is in compliance with the exemption order passed by SEBI. The said confirmation shall be furnished to the Target Company, which it shall disclose prominently as a note to the shareholding pattern filed for the quarter ended March 31 each year under regulation 31 of SEBI (Listing Obligations and Disclosure Requirements) 2015. In view of the above the Company has received Annual Compliance certificate from Rohit Relan Family Trust for the year ended March 31, 2026, certifying the compliance with the above mentioned Exemption Order.
